This Special Temporary Authorization is granted upon the express condition that it may be terminated by the Commission at any time without advance notice or hearing if in its discretion the need for such action arises. - (3) 3G Wireless, LLC should be aware that the band 2200-2290 MHz is allocated for federal operations and is an extremely congested band. Non-federal use is on a case-by-case basis with approval of requests for operational and long-term use being highly unlikely. 3G Wireless, LLC should have no expectations of approval in this band in future submissions.
