NAME Alion Science and Technology

This Special Temporary Authorization is granted upon the express condition that it may be terminated by the Commission at any time without advance notice or hearing if in its discretion the need for such action arises. Nothing contained herein shall be construed as a finding by the Commission that the authority herein granted is or will be in the public interest beyond the express terms hereof.

This Special Temporary Authorization shall not vest in the grantee any right to operate the station nor any right in the use of the frequencies designated in the authorization beyond the term hereof, nor in any other manner than authorized herein. Neither the authorization nor the right granted hereunder shall be assigned or otherwise transferred in violation of the Communications Act of 1934. This authorization is subject to the right of use of control the Government of the United States conferred by Section 706 of the Communications Act of 1934.

Special Temporary Authority is hereby granted to operate the apparatus described below:

Purpose Of Operation:

Demonstrate to Marine Corps personnel performance of a short-range, man-portable radar system capable of detecting personnel and vehicles amid brush and foliage.

- (2) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.

Special Conditions:

- (3) Alion Science and Technology shall obtain consents from the Broadband Radio Service licensees prior to operation in 2496-2500 MHz band.
- (4) Alion Science and Technology shall coordinate with the local Society of Broadcast Engineers frequency coordinator and the Fixed Microwave Service licensees prior to operation in 2450-2500 MHz band.
- (5) Any intended use of the frequencies requires prior coordination with the Fort Huachuca Spectrum Manager (520.538.8117) no less than three days prior to intended use, and due to ongoing and scheduled test and training events the frequencies may not be available for all time periods.
