- (1) Licensee is authorized to use various emissions and bandwidths during the experiment.
- (2) Operation is subject to prior coordination with the Associated Public Safety Communications Officers, Inc. (APCO); ATTN: Director of Frequency Coordination; 351 North Williamson Blvd.; Daytona Beach, FL 32114-1112; Telephone: (386) 322-2500.
- (3) Licensee must accept interference from others operating in the band and must not cause interference to FirstNet operations or those approved to operate in Band 14 per license (i.e. AT&T testing or public safety entities authorized to operate on Band 14).
- (4) Licensee POC shall submit a "Stop Buzzer" contact to FirstNet at peter.tomczak@firstnet.gov upon authorization issuance with "kill switch" authority; license POC agrees to immediately cease operations on Band 14 if notified of any interference concerns until any issues are resolved.
- (5) Licensee agrees that this license may be subject to further review by the FCC and possible re-coordination with FirstNet.
- (6) Licensee must prior coordinate testing with other authorized Band 14 operations. Failure to effectively coordinate shall result in FirstNet seeking immediate suspension of the experimental license by the FCC.

- (8) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (9) Operating powers for the applicable bands shall be in accordance with sections 27.50, 74.935, 74.939 and 101.113 of the FCC rules.
