- (2) The station identification requirements of Section 5.115 of the Commission's Rules are waived.
- (3) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.

- (8) The use of public safety frequencies listed under rule CFR 90.20 is prohibited.
- (9) Licensee must coordinate with Federal Aviation Administration Regional Office prior to renew this license.

- (12) Licensee is permitted using the frequency 332.75 MHz only in the band 328-336 MHz and restricted to it only in glide-slope band.
