Use of frequencies under the authority of this assignment is subject to such further coordination with the FAA Northwest Coordinator, Seattle, WA, as necessary to ensure compatibility with existing uses.
- (2) The station identification requirements of Section 5.115 of the Commission's Rules are waived.
- (3) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.

- (7) Operation is NOT permitted using the frequency band 406 MHz-406.1 MHz.
- (8) The use of public safety frequencies listed under rule CFR 90.20 is prohibited.

- (11) Operation is NOT PERMITTED using the following frequencies: 239.3 MHz, 243 MHz, 269.125 MHz, 273.45-273.6 MHz, 284.7 MHz, 285.45 MHz, 338.2 MHz, 978 MHz, and 328-336 MHz, 406-406.1 MHz.
- (12) Licensee is permitted using the frequency 332.75 MHz only in the band 328-336 MHz and restricted to it only in glide-slope band.
- (13) The applicant must exclude all FAA Air Traffic Control Annex A frequencies.

Special Conditions:

- (14) Operation is NOT PERMITTED using the frequency bands 190-435 KHz, 510-535 KHz, 74.800 -75.200MHz, 101-121.45 MHz, and 121.925-156.75 MHz.
