This Special Temporary Authorization is granted upon the express condition that it may be terminated by the Commission at any time without advance notice or hearing if in its discretion the need for such action arises. - (5) Prior to operation, licensee must coordinate with stations authorized to operate in these frequency bands that are located within a within a 25-mile radius of the transmitter.
