- (2) Licensee must secure consents from the Upper Microwave Flexible Use Service licensees in the proposed areas prior to accessing to 37.6-39 GHz band.
- (3) Unwanted emission mean power from operation in the 37-40 GHz frequency band shall be limited to -43 dB (W/MHz) and -23 dB(W/GHz) within the 36-37 GHz frequency band and is recommended to be less than -30 dB(W/GHz), in accordance with ITU Resolution 243 (WRC-19).
