- (5) Operation is limited to activity for the purpose of testing radionavigation satellite service (RNSS) equipment and systems.

- (7) The test equipment shall only be used indoors and shall be under the control of Cessna Aircraft Company.
- (8) Cessna Aircraft Company shall post signs on doors to the test area notifying that, "GPS re-radiator is in use and the GPS information you receive may be in error."
