- (3) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (4) Marketing of devices (as defined in 47CFR2.803 of this chapter) or provision of services for hire is not permitted.
- (5) All of the experimental devices will be retrieved by Vast Broadband from the participants upon completion of the operation.
- (6) This authorization is without prejudice to any determination that the Commission may make regarding pending or future experimental satellite earth station applications. Operations are on a non-interference basis (NIB) and shall not cause harmful interference to, and shall not claim protection from, interference caused to it by any other lawfully operating station and it shall cease transmission(s) immediately upon notice of such interference and notify the FCC in writing.
