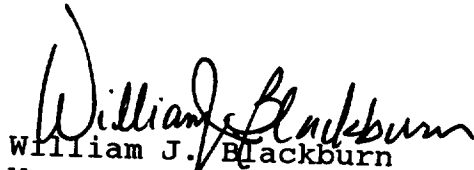
The convention booth demonstration will contain demonstration equipment in accordance with Attachment A.
