- (7) Licensee must comply with the requirements of Section 1.924(b)(1).
- (8) Licensee is authorized to operate up to 50 units per test without obtaining further approval from the Commission.
- (9) All operation on frequencies allocated to the satellite communications service must be prior coordinated in accordance with Sections 25.251, and 25.252.
- (10) All operation on frequencies allocated to the fixed microwave service must be prior coordinated with existing fixed microwave stations in accordance with Section 101.103(d).
