Subject to the provisions of the Communications Act of 1934, subsequent acts, and treaties, and all regulations heretofore or hereafter made by this Commission, and further subject to the conditions and requirements set forth in this license, the licensee hereof is hereby authorized to use and operate the radio transmitting facilities hereinafter described for radio communications in accordance with the program of experimentation described by the licensee in its application for license.

Special Conditions:

- (3) GPS re-radiators are limited to a maximum EIRP value that will result in power levels not to exceed a power spectral density of -140 dBm/24 MHz measured at a distance of 100 ft from the building where the test is being conducted. Any malfunction, misalignment, or tampering of the equipment or its location which results in an increased power spectral density outside the building could cause harmful radio frequency interference to GPS receivers, including those in aircraft and/or ground based facilities.
- (4) Operation is limited to activity for the purpose of testing radionavigation satellite service (RNSS) equipment and systems.
- (5) The test equipment shall only be used indoors and shall be under the control of General Dynamics OTS (Aerospace), Inc.
- (6) General Dynamics OTS (Aerospace), Inc. shall post signs on doors to the test area notifying that, "GPS re-radiator is in use and the GPS information you receive may be in error
- (7) GPS users in the area of potential interference to GPS reception must be notified that GPS information may be impacted for periods of time.
- (8) Stop buzzer point of contact is Eric Thome, (206) 455-4238.
- (9) This authorization is issued for the express purpose of conducting experimental operations described in the related application and required by the U.S. Government, W15QKN-18-9-1008 and DOTC-19-04-INIT4268 . The use of this radio station in any other manner or for any other purpose will constitute a violation of the privileges herein authorized. Except as subsequently authorized by the Commission, this radio station shall not be operated after the expiration date of the contract designated in the related application and enumerated above.
