- (5) All transmitting and/or receiving equipment used in the study shall be owned by the licensee.
- (6) Licensee is required to ensure that trial devices are either rendered inoperable or retrieved by them from trial participants at the conclusion of the trial. Licensee is required to notify trial participants in advance that operation of the trial device is subject to this condition.
- (7) Licensee may not involve more than 20% of its customers in this market trial.
- (8) This license will not be renewed.
