NAME Kratos Unmanned Aerial Systems

This Special Temporary Authorization is granted upon the express condition that it may be terminated by the Commission at any time without advance notice or hearing if in its discretion the need for such action arises. Nothing contained herein shall be construed as a finding by the Commission that the authority herein granted is or will be in the public interest beyond the express terms hereof.

This Special Temporary Authorization shall not vest in the grantee any right to operate the station nor any right in the use of the frequencies designated in the authorization beyond the term hereof, nor in any other manner than authorized herein. Neither the authorization nor the right granted hereunder shall be assigned or otherwise transferred in violation of the Communications Act of 1934. This authorization is subject to the right of use of control the Government of the United States conferred by Section 706 of the Communications Act of 1934.

Special Temporary Authority is hereby granted to operate the apparatus described below:

Purpose Of Operation:

This work is in support of DoD programs as a supplement to flight operations at Government ranges. Our maximum operating altitude is approximately 15,575 feet AGL.

Special Conditions:

- (1) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (2) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (3) All Kratos Unmanned Aerial Systems testing, shall not cause harmful interference to, and shall not claim protection from, interference caused to it by any other authorized operating stations and it shall cease transmission(s) immediately upon notice of such interference.
- (4) The Kratos Unmanned Aerial Systems stop buzzer contact for STA, Mr. Casey Thomas, (405) 845-7839, or by mobile phone at (405) 308-7440, shall be available during any durations of the testing.
- (5) Kratos Unmanned Aerial Systems should be aware that the band 2200-2290 MHz is allocated for federal operations and is an extremely congested band. Non-federal use is on a case-by-case basis with approval of requests for operational and long-term use being highly unlikely.
- (6) Further requests for extension of the authority granted herein must be filed on Form 442, "Application for New or Modified Radio Station Authorization under Part 5 of FCC Rules - Experimental Radio Service." Future STA requests to extend this authorization will not be considered.
