- (5) Coordination with existing commercial FS operators within 50 miles required.
- (6) Grant of this application does not prejudice Commission action on future applications.
- (7) Further requests for extension of the authority granted herein must be filed on Form 442, "Application for New or Modified Radio Station Authorization Under Part 5 of FCC Rules - Experimental Radio Service." Future STA requests to extend this authorization will not be considered.
