Special Conditions:

- (3) Licensee shall maintain a pointing error of less than 0.2° , between the orbital location of the target satellite and the axis of the main lobe of the earth station antenna. All emissions from the earth station shall automatically cease within 100 milliseconds if the angle between the orbital location of the target satellite and the axis of the main lobe of the earth station antenna exceeds 0.5° , and transmission will not resume until such angle is less than 0.2° .
- (4) In accordance with Article 4.4 of the ITU Radio Regulations, the operations authorized herein shall not cause harmful interference to, and shall not claim protection from harmful interference caused by, a station operating in accordance with the provisions of the ITU Constitution, the ITU Convention, and the ITU Radio Regulations.
- (5) Licensee shall comply with the EIRP density criteria set forth in Part 25.222(a)(1) through (a)(4) of the FCC's rules.
- (6) Point of communication(s): AMC-16 ; AMC-15 ; Anik F3 ; EchoStar 9 ; Spaceway 3 ; Jupiter 2 ; Jupiter 1.
- (7) The designated point-of-contact to terminate transmissions if interference occurs is Mr. Bernd Friedrich at (703) 340-5791 and (425) 896-3703.
- (8) Operation must be prior coordinated with Goddard Space Flight Center (GSFC) spectrum manager at (301) 286-5089.
- (9) Operation must be prior coordinated with NASA within 100 KM of Edwards, CA. POC (661) 276-2138 or (661) 276-2947.
- (10) Operation must be ceased if it causes harmful interference to NASA's operations in White Sands NM, Blossom Point MD, and Guam.
- (11) Coordination may be required with Cuba or other Caribbean countries.
- (12) Operation is subject to immediate cessation, if it causes harmful interference to the US Navy operations.
