This Special Temporary Authorization is granted upon the express condition that it may be terminated by the Commission at any time without advance notice or hearing if in its discretion the need for such action arises. - (2) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (3) Secure consents from the EBS/BRS licensees prior to accessing to 2500-2570 MHz and 2620-2690 MHz bands.
- (4) Coordinate the operation with the existing users in 71-76 GHz and 81-86 MHz bands prior to operation in 71-76 MHz and 81-86 MHz bands
- (5) Operation is not permitted in the band: 904-926 MHz.
- (6) Further requests for extension of the authority granted herein must be filed on Form 442, "Application for New or Modified Radio Station Authorization under Part 5 of FCC Rules - Experimental Radio Service." Future STA requests to extend this authorization will not be considered.
