Special Conditions:

- (1) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (2) The station identification requirements of Section 5.115 of the Commission's Rules are waived.
- (3) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (4) L3HARRIS TECHNOLOGIES, INC. must successfully coordinate with the local Society of Broadcast Engineers frequency coordinator in each proposed area prior to operation in 19.2- 21.2 GHz band.
- (5) L3HARRIS TECHNOLOGIES, INC. must successfully coordinate with Fixed Microwave Service licensees in each proposed area in accordance with 47 C.F.R, Part 101.103(d) prior to operation in 4-4.2 MHz, 5.85-6.425 GHz, 10.95-12.75 GHz, 19.2-21.2 GHz, and 29-31 GHz.
- (6) Prior to commencing any operations on 5850-6425 MHz band, the L3HARRIS TECHNOLOGIES, INC. must notify the earth station licensee operating in the 5894-5899 MHz and 5919-5927 MHz frequency bands the test dates and provide a stop buzzer in case of interference.

Special Conditions:

- (7) This authorization is issued for the express purpose of conducting experimental operations described in the related application and required by USSOCOM, Contract Number H92401-20-2-0002 and US Army, Contract Number W56JSR-17-D-0006. The use of this radio station in any other manner or for any other purpose will constitute a violation of the privileges herein authorized. Except as subsequently authorized by the Commission, this radio station shall not be operated after the expiration date of the contract designated in the related application and enumerated above.
- (8) Operation on this assignment is subject to immediate cessation, if it causes harmful interference to NASA125541, HIWRAP radar assignments.
- (9) The designated point-of-contact to terminate transmissions if interference occurs is Joe Upatham at (585) 742-9709.
- (10) Prior to commencing any operations on 14-14.5 GHz and 29-31 GHz bands, L3HARRIS TECHNOLOGIES, INC. must notify the earth station licensees the test dates and provide a stop buzzer in case of interference.
- (11) Any outdoor transmissions shall cease when the NASA International Space Station (ISS) (NORAD ID 25544) is visible.
- (12) To protect space-based passive sensing, the unwanted emission power shall not exceed -38 dBw in any 100 MHz of the 31.3-31.5 GHz band.
