Special Conditions:

- (1) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (2) Operation in the 824-849 or 869-894 MHz band requires consent of local cellular licensee(s) to avoid interference.
- (3) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (4) Maintain separation from the grandfathered earth stations as defined in Part 90 subpart Z, or coordinate an agreement with the grandfathered earth station licensees prior to operation in 3650-3700 MHz.
- (5) Ensure that the operations will not cause harmful interference to any existing registered stations in the 3650-3700 MHz, and notify the registered users in the area.
- (6) Secure consents from the AWS licensees prior to accessing to 2120-2200 MHz.
- (7) Coordinate with the local SBE frequency coordinator and with the Fixed Microwave Service licensees in accordance with 47 CFR, Part 101.103(d) prior to operation in the rest of the requested frequency bands.
- (8) No operation permitted in frequency bands 6.0-6.2 MHz and 7.3-7.4 MHz.
- (9) The following frequency bands must be notched out:
162.2625-162.3125 MHz
162.3375-162.3625 MHz
162.4625-162.4875 MHz
- (10) Operation is subject to notification of the Location & Monitoring Service licensees (902-928 MHz) within 50 miles of the test area.
