Special Conditions:

- (1) Assignment on 1030 MHz or in one of the bands 1215-1400, 2700-2900, or 9000-9200 MHz was coordinated prior to authorization with the FAA Eastern Coordinator, New York, NY. Use of frequencies under the authority of this assignment is subject to such further coordination with the FAA Eastern Coordinator, New York, NY, as necessary to ensure compatibility with existing uses.
- (2) The station identification requirements of Section 5.115 of the Commission's Rules are waived.
- (3) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (4) For the Syracuse location NL 43-06-43; WL 76-11-18, frequency band 1215-1400 MHz TRANSMISSIONS ARE LIMITED TO THE DIRECTION OF 115-170 DEGREES AND 195-210 DEGREES REFERENCED TO TRUE NORTH.

For the Syracuse location NL 43-06-43; WL 76-11-18, frequency bands 1261-1289 MHz and 1353-1392 MHz TRANSMISSIONS ARE LIMITED TO THE DIRECTION OF 20-50 DEGREES REFERENCED TO TRUE NORTH.

For the South Syracuse location NL 42-55-37; WL 75-55-27, TRANSMISSIONS ARE LIMITED TO THE DIRECTION OF 80-170 DEGREES REFERENCED TO TRUE NORTH.

- (5) Operation is limited to pulse duration of 25-2000 microseconds and pulse repetition rate of 500-10000 pps, except as it is indicated in Special Condition No.(6).
- (6) For the Syracuse location NL 43-06-43; WL 76-11-18, frequency bands 1261-1289 MHz and 1353-1392 MHz, operation is limited to pulse duration of 2.0 microseconds and pulse repetition rate of 1-1000 pps.
- (7) This license SUPERSEDES the previously issued license with the same call sign and file number: to add and remove Special Conditions.
