Special Conditions:

- (1) Operation in the 1695-1780 MHz, 1915-1920 MHz, 1995-2020 MHz or 2110-2200 MHz band requires consent of local Advanced Wireless Service (AWS) licensee(s) to avoid interference.
- (2) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (3) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (4) Operation is subject to prior coordination with the local Society of Broadcast Engineers, Inc. (SBE) frequency coordinator. Consult the list at https://www.sbe.org/sections/freq_local.php to find the appropriate coordinator.
- (5) Lockheed Martin Corporation must notch out the requested frequency of 1600 MHz in order to protect GPS L1 operations.
- (6) Coordinate with Fixed Microwave Service licensees in accordance with 47 C.F.R, Part 101.103(d) prior to operation on 3950 MHz, 6000 MHz, and 18000 MHz.

Special Conditions:
