The use of this radio station in any other manner or for any other purpose will constitute a violation of the privileges herein authorized. Except as subsequently authorized by the Commission, this radio station shall not be operated after the expiration date of the contract designated in the related application and enumerated above.
- (4) Operations on 1030 MHz will be in accordance with the following restrictions:
 - a) PRR = 175 pps
 - b) Pulse Duration = FX 0.8 usec
 - c) Only modes 1,2,3A and C are allowed
 - d) Direction of interrogation must be between 0 and 90 degree reference to True North
