- (3) Identifications for selective calling: Coast Station Identify, 003660100; Coast Station Identification Number, 1146.
- (4) In the bands 4-27 MHz and 156-157.5 MHz, the licensee is only authorized those channels and types of operations as per Part 80 of the FCC Rules.
- (5) The frequency 2183.4 kHz is to be used for distress, safety and calling only.
