Special Conditions:

- (1) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (2) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (3) Licensee shall prior coordinate with the incumbent fixed microwave in each corresponding proposed venue prior to conducting the testing.
- (4) Prior to operation, licensee must coordinate with satellite stations authorized to operate in these frequency bands that are located within a 25 mile radius of the transmitter.
- (5) Licensee must avoid pointing the main beam transmitting antenna within 10 degrees of any point on the geostationary orbit arc in the 38.6-40 GHz band.
- (6) Licensee should be aware that other stations are licensed on 38.6-40 GHz band and if any interference occurs, the experimental licensee of this authorization will be subject to immediate shut down.
- (7) Prior to commencing any operations, the applicant must coordinate with the Fixed Microwave Service licensees in each proposed location in accordance with 47 C.F.R, Part 101.103(d) prior to operation in 38.6-40 GHz band to protect the microwave service operations.

Special Conditions:

- (8) Prior to operation, experimental licensee, must notify licensees of FSS earth stations operating the 3700-4200 MHz within 10-kilometer radius of the locations from which experimental operations will occur. Experimental licensee must also provide such notification to the National Spectrum Managers Association frequency coordinators by email. (see http://wireless.fcc.gov/services/index.htm?job=licensing_1&id=microwave). The notice must include the name and contact information of the stop buzzer personnel that will be available to cease operations in the event of reported interference. The notification should include the testing parameters (specific location(s), antenna gain(s), antenna pattern, antenna height(s), antenna orientation, eirp density) and day and times of each test. Consult the IBFS database to identify licensed earth station in the band 3700-4200 MHz band.
- (9) The experimental stations power flux-density (pfd) at FSS earth stations must not exceed -154.5 dB (W/(m² · 4 kHz)).

- (11) Operation in the 38.6-40.0 GHz band must comply with the unwanted emission power levels of ITU Resolution 243.
