- (2) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (3) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (4) For 3000-3100 MHz operation: pw = 15, 90, 245 usec; prf = 250, 275, 300, 650, 825 Hz.
- (5) For 1030 MHz operation: pw = 0.8 usec; prf = 250, 275 Hz; blank sector from 45-70 degrees referenced to true north.
- (6) This frequency assignment on 1030 MHz was coordinated prior to authorization with the FAA Eastern Coordinator, New York, New York. Use of this frequency under the authority of this assignment is subject to such further coordination with the FAA Eastern Coordinator, New York, New York, as necessary to ensure compatibility with existing uses.
