- (2) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (3) The station identification requirements of Section 5.115 of the Commission's Rules are waived.
- (4) This authorization is issued for the express purpose of conducting experimental operations described in the related application and required by U.S. Navy contract number N00174-97-D-0009. The use of this radio station in any other manner or for any other purpose will constitute a violation of the privileges herein authorized. Except as subsequently authorized by the Commission, this radio station shall not be operated after the expiration date of the contract designated in the related application and enumerated above.
- (5) The frequencies 2371.5 MHz and 2378.5 MHz were coordinated prior to authorization with the HQ USAF Frequency Coordinator, Alexandria, VA., who also coordinated it, as appropriate, with the Aerospace and Flight Test Radio Coordinating Council. Use of this frequency under the authority of this assignment is subject to such further coordination with the HQ USAF Frequency Coordinator, Alexandria, VA., as necessary to ensure compatibility with existing uses.
- (6) The frequencies 2371.5 MHz and 2378.5 MHz were coordinated prior to authorization with with AFMO CONUS, Ft. Sam Houston, Texas, who also coordinated it, as appropriate, with the Aerospace and Flight Test Radio Coordinating Council. Use of this frequency under the authority of this assignment is subject to such further coordination with AFMO CONUS, Ft. Sam Houston, Texas, as necessary to ensure compatibility with existing uses.
