Special Conditions:

- (1) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (2) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (3) This authorization is issued for the express purpose of conducting experimental operations described in the related application and required by Defense MicroElectronic Activity Contract Number HQ0727-16-D-0004. The use of this radio station in any other manner or for any other purpose will constitute a violation of the privileges herein authorized. Except as subsequently authorized by the Commission, this radio station shall not be operated after the expiration date of the contract designated in the related application and enumerated above.
- (4) Experimental station shall use the minimum power level necessary to establish communications links to minimize potential interference to licensed users.
- (5) Licensee shall be aware that FSS earth stations are licensed above 3700 MHz and if any interference occurs, the experimental licensee of this authorization will be subject to immediate shut down.
