- (3) All radiation on 1030 MHz must be confined to 275-310 degrees reference to true north. All other azimuth angles must be blanked.
- (4) 2kw represents the max allowed Tx power on 1030 MHz, Tx power should be adjusted to that necessary to cover the 108 nm.
