This Special Temporary Authorization is granted upon the express condition that it may be terminated by the Commission at any time without advance notice or hearing if in its discretion the need for such action arises. This Special Temporary Authorization shall not vest in the grantee any right to operate the station nor any right in the use of the frequencies designated in the authorization beyond the term hereof, nor in any other manner than authorized herein. Neither the authorization nor the right granted hereunder shall be assigned or otherwise transferred in violation of the Communications Act of 1934. This authorization is subject to the right of use of control the Government of the United States conferred by Section 706 of the Communications Act of 1934.

Operation of a trial 700 MHz LTE network for use in the development of solutions intended to advance the FirstNet program and the development of the FirstNet Nationwide Network.

Special Conditions:

- (1) This temporary operation will not be used in mission-critical operations or in the delivery of live transmissions in duties to protect life, property, or safety.
- (2) Given the fact that FirstNet recently has entered into a Spectrum Manager Lease Agreement (SMLA) with New Jersey, it is possible that interference from the proposed STA will be experienced by New Jersey's operations under the SMLA. To mitigate the risk of harmful interference, FirstNet can request the FCC to order the licensee to cease operations upon notice and no later than within 24 hours of said notice.
