for a New Experimental Radio Service Authorization and a Request for
Confidential Treatment of the Application.**

Dear Madam Secretary:

On behalf of Northrop Grumman Corporation ("Northrop Grumman"), there is submitted herewith, on FCC Form 442, an application for a new experimental radio service authorization under Part 5 of the Commission's Rules.

Northrop Grumman is applying for this new authorization in order to fulfill various purchase orders with Lockheed Martin Tactical Aircraft Systems to design, construct and test APG-68VXm radar systems for use in F-16 aircraft contracted for sale to the governments of Greece and Israel, and potentially the United States Department of Defense. Because Exhibit I to Northrop Grumman's Form 442 application contains information that has been classified by the United States Department of Defense, Exhibit I will be submitted to the Commission's Security Operations Staff.

Specifically, the information contained in Exhibit 1 has been classified as "Confidential" by the Department of Defense's F-16 Security Guide pursuant to Executive Order 12958. This information is exempt from routine declassification pursuant to its X3 status. Accordingly, pursuant to Section 552(b)(1) of the Administrative Procedure Act, 5 U.S.C. § 552(b)(1), and Section 0.457 of the Commission's rules, 47 C.F.R. § 0.457(a), Northrop Grumman requests that that Exhibit I be treated as "Confidential" for national security purposes and withheld from the public.
