Special Conditions:

- (1) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (2) Further requests for extension of the authority granted herein must be filed on Form 442, "Application for New or Modified Radio Station Authorization under Part 5 of FCC Rules - Experimental Radio Service." Future STA requests to extend this authorization will not be considered.
- (3) Prior to commencing any operations in the 1850-1860 MHz and 1930-1940 MHz bands, the licensee must obtain consent from Broadband PCS A block licensees (1850-1865 MHz/1930-1945 MHz) within 50 miles of the contours of the testing area.
- (4) Prior to commencing any operations in the 3720-3730 MHz band, the licensee must obtain consent from licensees in this sub-band of 3.70 GHz band licensees (3.70-3.98 GHz) within 50 miles of the contours of the testing area.
- (5) Coordinate with the local Society of Broadcast Engineers frequency coordinator in the proposed areas prior to operation in the 670-690 MHz and 480-490 MHz bands.
- (6) Notify the 600 Megahertz Band licensees (Service Code: WT) in each proposed area prior to accessing to the frequency range from 670 MHz to 690 MHz.
- (7) Notify the Advanced Wireless Service licensees in the proposed areas prior to accessing to 1710-1720 MHz and 2110-2120 MHz bands.
- (8) Prior to commencing any operations in the 902-928 MHz band, the licensee must obtain consent from Location & Monitoring Service licensees (902-928 MHz) within 50 miles of the contours of the testing area.
- (9) Operations for Electronic Attacks, Electronic Warfare and Countermeasures (EW and ECM) are NOT allowed.

Special Conditions:

- (10) Prior to commencing operations in the authorized frequency band(s), the experimental licensee must notify the potentially affected licensees below. The notice must include the name and contact information of the stop buzzer personnel that will be available to cease operations in the event of reported interference. The notification should also include the testing parameters (e.g., specific location(s), frequency bands, antenna gain(s), antenna height(s), antenna orientation, EIRP, EIRP density) and day and times of each test.
