- (3) Maintain separation from grandfathered earth stations as defined in Part 90, Subpart Z, or coordinate and agreement with the grandfathered earth stations licensees.
- (4) Consult ULS database to ensure that the operations will not cause harmful interference to any existing registered stations in 3650-3700MHz, and notify registered users in the area.
