AFTRCC recommends the FCC add the following restriction(s) to the grant of this authorization:

SPECIAL CONDITION: Scheduling required for each usage with Western Area Frequency Coordinator, Tel: (805) 989-1003 or (805) 989-7985, prior to operation. Failure to comply with the FCC restrictions may subject the user to fines and forfeitures.

As a condition for this coordination, AFTRCC requires that QUALCOMM INC. will not offer for sale, MediaFLO systems or similar equipment, which would operate in the frequency bands 1435 to 1525 MHz, and/or 2310 to 2395 MHz within the United States. QUALCOMM INC. must also accept any interference to their testing caused by aeronautical telemetry flight test operations, and must not cause interference to the same.
