Special Conditions:

- (1) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (2) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (3) The 1390 – 1400 MHz band shall not be used to simulate airborne operations in accordance with Footnote US79.
- (4) All operations in the 1370-1400 MHz band shall comply with the limits of unwanted emission recommendations specified in ITU Resolution 750 (Rev. WRC-19).
- (5) Further requests for extension of the authority granted herein must be filed on Form 442, "Application for New or Modified Radio Station Authorization under Part 5 of FCC Rules - Experimental Radio Service." Future STA requests to extend this authorization will not be considered.
- (6) The stop buzzer POC is Jim Ortega at (520) 794-0227.
- (7) This authorization is issued for the express purpose of conducting experimental operations described in the related application and required by the U.S. Government; contract number HR001120C0008. The use of this radio station in any other manner or for any other purpose will constitute a violation of the privileges herein authorized. Except as subsequently authorized by the Commission, this radio station shall not be operated after the expiration date of the contract designated in the related application and enumerated above.
