- (2) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (3) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (4) Airborne emissions in the 1390-1400 MHz frequency band are not permitted in accordance with Footnote US79.
- (5) Operation in the 1362-1400 MHz frequency band shall comply with the limits of unwanted emission recommendations specified for mobile stations in ITU Resolution 750 (Rev. WRC-19).

- (7) Raytheon Company (Missiles and Defense - M) must operate in accordance with FAA WebFCR coordination's NG T210220 thru NG T210225.
