- (4) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (5) This authorization is issued for the express purpose of conducting experimental operations described in the related application and required by Navy contract number: N00024-07-C5444. The use of this radio station in any other manner or for any other purpose will constitute a violation of the privileges herein authorized. Except as subsequently authorized by the Commission, this radio station shall not be operated after the expiration date of the contract designated in the related application and enumerated above.
- (6) Operation is subject to prior coordination with the existing and future Fixed Microwave Service licensees in accordance with 47 CFR, Part 101.103(d).
- (7) All transmissions shall be directed away from geostationary orbits to avoid interference to satellites.
