- (3) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (4) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (5) Raytheon SAS coordinate with the local Society of Broadcast Engineers frequency coordinator prior to operation on 158.45 MHz and 173.2 MHz..
- (6) Operation is subject to consent of the following within 50 miles of the test area:
 - All services in 220 MHz,
 - 220-222 MHz Service,
 - Paging Service licensees in 43 MHz, 158 MHz, and 152 MHz/158 MHz.
