The use of this radio station in any other manner or for any other purpose will constitute a violation of the privileges herein authorized. Except as subsequently authorized by the Commission, this radio station shall not be operated after the expiration date of the contract designated in the related application and enumerated above.
- (3) The station identification requirements of Section 5.115 of the Commission's Rules are waived.
- (4) Licensee is authorized to use various modes of modulation, bandwidth, and data rates. None of these modes of transmission shall extend beyond the band limits set forth above. Power and emission for the 902-928, 2400-2483.5 and 5725-5850 MHz bands must conform to Part 15 FCC Rules.
- (5) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (6) Any operation in the 1850-1990 and 2130-2200 MHz band must be coordinated with the existing and future users to avoid interference. Emission types may vary under the experiment.
- (7) Subject to coordination with the Area Frequency Coordinator, located at the Army Electronic Proving Ground, Ft. Huachuca, Arizona, prior to use within the State of Arizona. Phone: 602-538-6423.
- (8) All customers participating in the experiment shall be informed that this operation is for experimental purposes only and can be cancelled at any time.
- (9) Assignment in frequency bands 960-1400, 2700-2900, or 9000-9200 MHz was coordinated prior to authorization with the FAA Western Coordinator, Los Angeles, CA. Use of frequencies under the authority of this assignment is subject to such further coordination with the FAA Western Coordinator, Los Angeles, CA, as necessary to ensure compatibility with existing uses.
- (10) This authorization is issued for the express purpose of conducting experimental operations described in the related application and required by U.S. Navy Contract number N00019-87-C-3102. The use of this radio station in any other manner or for any other purpose will constitute a violation of the privileges herein authorized. Except as subsequently authorized by the Commission, this radio station shall not be operated after the expiration date of the contract designated in the related application and enumerated above.
