Special Conditions:

- (1) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (2) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (3) All customers participating in the experiment shall be informed that this operation is for experimental purposes only and can be cancelled at any time.
- (4) Raytheon shall assure that adequate guard bands are provided between the band edges of its carriers and the band edges of MSV's operations in order to preclude the possibility of unacceptable interference to MSV's operations.
- (5) Neither the aggregate uplink EIRP densities in the direction of any other L-band satellite serving the United States, nor the downlink EIRP densities at any geographical point within the United States, shall be increased as a result of the addition of experimental BGAN operations on the Inmarsat 4F2 satellite over those densities previously authorized on the Inmarsat 3F4 satellite.
- (6) Raytheon shall notify MSV prior to commencing operations and identify its point of contact.
- (7) POINT OF COMMUNICATION: INMARSAT 4F2 Satellite.
