This Special Temporary Authorization is granted upon the express condition that it may be terminated by the Commission at any time without advance notice or hearing if in its discretion the need for such action arises. This Special Temporary Authorization shall not vest in the grantee any right to operate the station nor any right in the use of the frequencies designated in the authorization beyond the term hereof, nor in any other manner than authorized herein. - (1) Operation in the 1695-1780 MHz, 1915-1920 MHz, 1995-2020 MHz or 2110-2200 MHz band requires consent of local Advanced Wireless Service (AWS) licensee(s) to avoid interference.
- (2) Licensee is required to coordinate operations with existing microwave users in the area to avoid interference.
- (3) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.

- (5) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (6) Prior to commencing any operations, the licensee must obtain consent from the following within 50 miles of the contours of the testing area:
 - 700 MHz Upper Band licensees (775-788 MHz)
