- (2) The station identification requirements of Section 5.115 of the Commission's Rules are waived.

Special Conditions:

- (3) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (4) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (5) Operation in the 1695-1780 MHz, 1915-1920 MHz, 1995-2020 MHz or 2110-2200 MHz band requires consent of local Advanced Wireless Service (AWS) licensee(s) to avoid interference.
- (6) Prior to commencing any operations in the frequencies below, Rockwell Collins, Inc. must obtain consent from the following within 50 miles of the contours of the testing area:
 - Paging Service licensees in 35 MHz
 - Paging Service licensees in 43 MHz
 - 1390-92 MHz Band Licensees
 - 1392-1395 MHz/1432-1435 MHz Band licensees
- (7) Coordinate with the local Society of Broadcast Engineers frequency coordinator prior to operation in the frequency range from 54 MHz to 72 MHz.
- (8) All operations shall comply with the limits of unwanted emission recommendations specified in Resolution 750 (Rev.WRC-19).
