- (2) All customers participating in the experiment shall be informed that this operation is for experimental purposes only and can be cancelled at any time.
- (3) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (4) All transmitting and/or receiving equipment used in the study shall be owned by the licensee.
- (5) Prior to equipment authorization or a determination of compliance, the device must be accompanied by a conspicuous notice worded as follows: "This device has not been authorized as required by the rules of the Federal Communications Commission. This device is not, and may not be, offered for sale or lease, or sold or leased, until authorization is obtained."
- (6) The occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (7) Point of Communication: Inmarsat I-4F3 satellite (Call Sign S2932).
- (8) Operations of the authorized stations must be in compliance with the terms and conditions specified in the Inmarsat 4F3 geosynchronous L-band satellite grant of US market access, including any coordination agreements.
