(2) NTIA would like to comment for any future applications the following:

The current MSV license does not permit reverse band operations where mobile terminals transmit in the downlink band and base stations transmit in the uplink band. NTIA has developed an out-of-channel emission level of -90.3 dBW/4 kHz EIRP for mobile terminals operating in the 1525-1559 MHz band to protect satellite mobile earth terminals used by the Federal government.
