Subject to the provisions of the Communications Act of 1934, subsequent acts, and treaties, and all regulations heretofore or hereafter made by this Commission, and further subject to the conditions and requirements set forth in this license, the licensee hereof is hereby authorized to use and operate the radio transmitting facilities hereinafter described for radio communications in accordance with the program of experimentation described by the licensee in its application for license.

Special Conditions:

- (1) GPS re-radiators are limited to a maximum EIRP value that will result in power levels not to exceed a power spectral density of -140 dBm/24 MHz measured at a distance of 100 ft from the building where the test is being conducted. Any malfunction, misalignment, or tampering of the equipment or its location which results in an increased power spectral density outside the building could cause harmful radio frequency interference to GPS receivers, including those in aircraft and/or ground based facilities.
- (2) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (3) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.

Special Conditions:

- (4) Licensee shall maintain testing according to the NTIA requirements of section 8.3.28 as stated in the filed application.
- (5) GPS users in the area of potential interference to GPS reception must be notified that GPS information may be impacted for periods of time.
- (6) Textron Aviation shall post signs on doors to the test area notifying that, "GPS re-radiator is in use and the GPS information you receive may be in error."
- (7) The test equipment shall only be used indoors and shall be under the control of Textron Aviation Inc.
- (8) Operation is limited to activity for the purpose of testing radio navigation satellite service (RNSS) equipment and systems.
- (9) Stop Buzzers, Danny Hankins at 620-332-0432/620-870-9388; Doug Collins at 210-357-6130 and Ed Petit at 210-357-6120.
- (10) GPS re-radiators must operate in accordance with Section 8.3.28 of the NTIA Manual. Power spectral density of the signal should be very well controlled in the building.
