Special Conditions:

- (1) This frequency assignment in one of the bands 1435-1525, 2310-2320 and 2345-2390 MHz was coordinated prior to its authorization with AFMO CONUS, Ft. Sam Houston, TX, who also coordinated it, as appropriate, with the Aerospace and Flight Test Radio Coordinating Council. Use of this frequency under the authority of this assignment is subject to such further coordination with AFMO CONUS, Ft. Sam Houston, TX, as necessary to ensure compatibility with existing uses.
- (2) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.

Special Conditions:

- (3) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (4) Operations must be scheduled as a WSMR Range mission, through the appropriate WSMR Range sponsor prior to operations. Final authorization to radiate shall be contingent upon successful scheduling and de-confliction of spectrum with other area-wide operations.
- (5) Operation is subject to prior coordinate with local Raytheon Missile (Tucson).
- (6) Operation is subject to coordination with the area frequency coordinator,
