- (5) Prior to activation in Honolulu, HI, Boeing must coordinate with Randall Hall at 808-477-9609.
- (6) Operation is subject to prior coordination with NASA-White Sands Center (WSC) is required at least 7 days in advance with NASA WSC point-of-contact as designated by the NASA/GSFC spectrum manager, Scott Galbraith at 301-286-5089, VINCENT.S.GALBRAITH@NASA.GOV. For operations within 3 days, licensee may coordinate with the NASA-WSC operations center at 575-527-7157. Non interference basis to NASA space-ground operations.
- (7) Prior to activation, the applicant must coordinate with GSFC SPECT MANAGER, 301-286-5089
- (8) Operation is not permitted in Yuma, AZ and China Lake, CA.
- (9) During transmission, aircraft shall not exceed the altitude listed in the circuit marks field 37,000 ft. AGL.
- (10) Prior to activation, the applicant must coordinate with WAFC 760-939-6948.
