Special Conditions:

- (1) Operation in the 824-849 or 869-894 MHz band requires consent of local cellular licensee(s) to avoid interference.
- (2) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (3) Operation in the 1850-1910 or 1930-1990 MHz band requires prior frequency coordination with 2 GHz microwave users and consent of PCS licensees to avoid interference.
- (4) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (5) All aircrafts participating in this experiment shall be US-registered vessels.
- (6) The designated point-of-contact to terminate transmissions if interference occurs is Steve Uhrich at 206-650-2147.
- (7) Operation is NOT permitted on the frequency band 1755 MHz to 1850 MHz.
- (8) Licensee must get consent from the advanced wireless service licensees before experimental operation starts using the frequency 1710-1755 MHz.
