- (3) The designated point-of-contact to terminate transmissions if interference occurs is Patrick McCauley at 610-591-8907.
- (4) Licensee must get consents from the Advanced Wireless Service licensees prior to accessing to 2-2.31 GHz band.
- (5) Licensee must obtain consents from the Educational Broadband Services and Broadband Radio Services licensees prior to accessing to 2500-2690 MHz band.
- (6) Operation is subject to prior coordinate with the local Society of Broadcast Engineer frequency coordinator and the affected Fixed Microwave Service licensees prior to operation in 2450-2500 MHz and 3.7-4GHz bands
- (7) Operation the frequency band 2.39-2.69 GHz and 2.9-3.65 GHz is used the 0.00001W of ERP only.
