- (2) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (3) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (4) Operations in the bands 157.1875 - 157.4375 MHz and 161.7875 - 162.0375 MHz must be coordinated with the market-based licensee for the proposed site. In addition, any intended operations on the frequencies 161.975 and/or 162.025 MHz must be coordinated with the U.S. Coast Guard.
- (5) The designated point-of-contact to terminate transmissions if interference occurs is Harold Wehrman at 425-234-9643 and Thomas Chan at 206-662-0950.

Special Conditions:

- (6) Operation is NOT PERMITTED using the frequency band 75.3-75.4 MHz, 225-328.5 MHz and 335.4-399.9 MHz.
- (7) During transmission, aircraft shall not exceed 37,000 ft, AGL.
