- (1) Operation in the 824-849 or 869-894 MHz band requires consent of local cellular licensee(s) to avoid interference.

Special Conditions:

- (2) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (3) Operation in the 1710-1755 or 2110-2155 MHz band requires consent of local Advanced Wireless Service (AWS) licensee(s) to avoid interference.
- (4) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (5) Operation in the 1850-1910 or 1930-1990 MHz band requires prior frequency coordination with 2 GHz microwave users and consent of PCS licensees to avoid interference.
- (6) All aircrafts participating in this experiment shall be US-registered vessels.
- (7) The designated point-of-contact to terminate transmissions if interference occurs is Steve Uhrich at 206-650-2147.
- (8) Operation is NOT permitted on the frequency band 1710 MHz to 1785 MHz in the Glasgow, MT area due to cause harmful interference to federal operations.
- (9) Operation is NOT permitted on the frequency band 1755 MHz to 1785 MHz in all areas.
- (10) Licensee must coordinate with Western Area Frequency Coordinator at (760) 939-6948 prior to operation the frequency band 880-915 MHz and 1710-1755 MHz in Victorville, CA.
